Duane was notified that the state had received OSSSL's application for tax-exempt status. He noted that there are currently 11 men and 5 women listed on the website that are looking for a team.

Registrar's Report

Registrar Rich Cortez reported registration activity is slowing down as the season winds down.

Standing Committee Reports:

Disciplinary Committee

Rich reported on 2 red cards that were handled by the Disciplinary Committee:

• Carolina Rodriguez of the Union City Aztecs received a 2-game suspension for serious foul play in the May 31 game between the Aztecs and Fremont Clash.

• Courtney Wilkerson of the UC America received a 2-game suspension for serious foul play in the April 7 game between the America and Fremont Barcelona.

There are 3 red cards pending, and Rich would like to hold a Disciplinary Committee meeting immediately following tonight's Board meeting.

Tournament Committee

Fremont City Rep Jackie Sanchez reporting that the committee has been meeting to plan the tournament, which will be held on August 3 and 4. Registration should open soon, and the early registration fee will be \$575.

Duane reported that the June Cup will be played on June 23 and 24. Tournament organizer Danny Williams is trying to register at least 12 teams.
